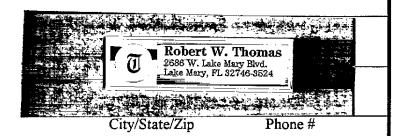

Articles of Incorporation

of

Thomas' Consolidated Industries, Inc.

I, Robert W. Thomas, Jr., being of legal age do hereby authorize the formation of a corporation under the laws of the State of Florida.

ARTICLE I.

The name of this corporation shall be THOMAS' CONSOLIDATED INDUSTRIES, INC.

ARTICLE II.

This corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE III.

GENERAL NATURE OF BUSINESS

The general nature of business to be transacted by this corporation is the manufacture and sale of nail polish removing devices, and to engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE IV.

CAPITAL STOCK
