ARTICLES OF INCORPORATION FOR
PSYCHOTHERAPY FOR THE SOUL, INCORPORATED

ARTICLE I: The name of this corporation is Psychotherapy for the Soul, Incorporated.

ARTICLE II: The existence of the corporation shall begin at the time these articles are registered in the State of Florida.

ARTICLE III: The principle place of business of the corporation shall be: 153 ½ North Congress Avenue, Boynton Beach, Florida 33426

ARTICLE IV: The maximum number of shares this corporation is authorized to issue is One Hundred (100), all of which shall be common shares. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.
