5. The registered agent of the corporation is Marek Blahusek and the registered address is 19135 US 19 N., Apt. D-2, Clearwater, FL 33764.

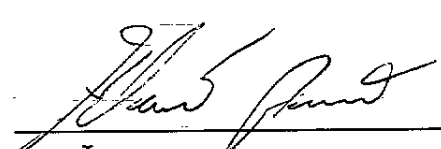
6. The initial Board of Directors shall have one member whose name and address is as follows:

The number of directors may be raised or lowered by amendment of the bylaws of the corporation but shall in no case be less than one.

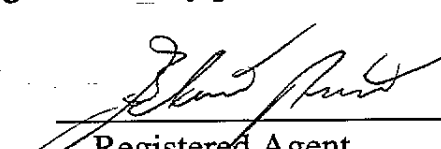
