The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The corporation shall indemnify any officers or directors or any former officers or directors to the full extent permitted by law.


ARTICLE X - I.R.C. STOCK PROVISION
