# ARTICLES OF INCORPORATION SECRETARY OF STATE TALLAHASSEE, FLORIDA

# KAPIL INC. OF U.S.A.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: KAPIL INC. OF U.S.A., 1695 Eastern Road, South Daytona, Florida 32119.

ARTICLE II. TERM OF EXISTENCE: The period of its duration is perpetual.


