ARTICLE I. NAME

The name of this corporation is LaTeve.com, Inc.

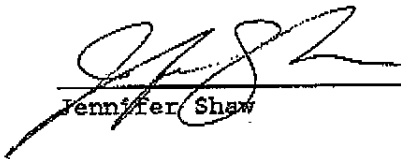
ARTICLE IX. INDEMNIFICATION

ARTICLE X. AMENDMENT

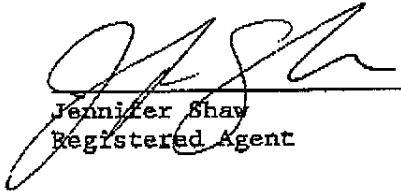
