ARTICLES OF INCORPORATION 24

OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

# ARTICLE ONE

The name of the corporation is PRICE BUILDING MAINTENANCE INC., a Florida Corporation.

## ARTICLE TWO

The duration of the corporation is perpetual.

The general nature of the business to be transacted by this corporation shall be:
