ARTICLE I

The name of the corporation is ED HOTEL PARTNER, INC., (hereinafter called the "Corporation").

ARTICLE II

This Corporation shall have authority to issue One Thousand (1,000) shares of Common Stock having a par value of \$0.01 per share.

ARTICLE VII

This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.
