ARTICLE IX. OFFICERS



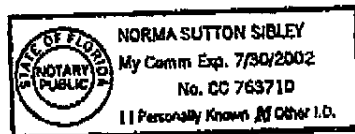


