

ARTICLE I - NAME

The name of the Corporation shall be Consider It Done Management Company, with its principal place of business located at 801 Xanadu Place, Jupiter, Florida 33477.

ARTICLE II - DURATION

The Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

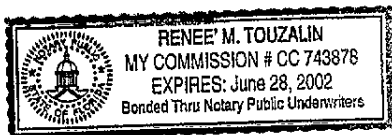
