ARTICLES OF INCORPORATION
OF
ALACHUA PAWN & JEWELRY, INC.

In compliance with the requirements of Chapter 607, Fla.Stat., the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I
NAME

The name of the corporation is ALACHUA PAWN & JEWELRY, INC.

ARTICLE II
INITIAL PRINCIPAL OFFICE

The street address of the initial principal office of the Corporation is 728 N.W. 8th Avenue, Gainesville, FL 32601.

ARTICLE III
DURATION

The corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed except that if these Articles are not filed by the Florida Department of State within five (5) business days after they are executed, corporate existence shall commence when they are so filed.

ARTICLE IV
AUTHORIZED SHARES

This Corporation is authorized to issue a maximum of 100 shares, all of which shall be common shares, identical with each other in every respect. The holders of common shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V
INITIAL REGISTERED OFFICE AND AGENT

The initial bylaws of the corporation shall be adopted by the directors.


