**ARTICLE I - NAME**

The name of this corporation is DAN WRIGHT COMMUNICATIONS, INC.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence commencing on June 25, 1999

**ARTICLE III - PURPOSE**

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE IV - CAPITAL STOCK**

This Corporation is authorized to issue 7,500 shares of one penny (\$.01) par value common stock, which shall be designated "Common Shares."

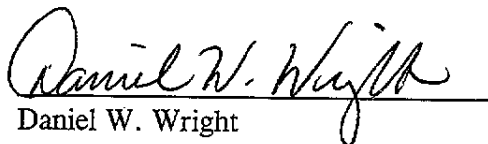
