**ARTICLES OF INCORPORATION  
OF  
NATIONAL CORP SERVE, INC.**

I, THE UNDERSIGNED, hereby subscribed to the following document for the purpose of forming a corporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges, and immunities of a corporation for profit.

**ARTICLE I.**

The name of the corporation shall be National CorpServe, Inc.

**ARTICLE II.**

The street address of the initial principal office of this corporation is 7860 Peters Road, Suite F-107, Plantation, Florida 33324 and the name and address of the initial registered agent of this corporation is Tony DuBose, 7860 Peters Road, Suite F-107, Plantation, Florida 33324.

The Board of Directors may from time to time move the principal office to any other address in Florida.

**ARTICLE III.**

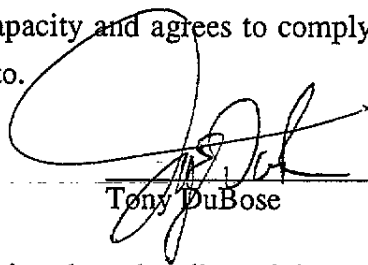

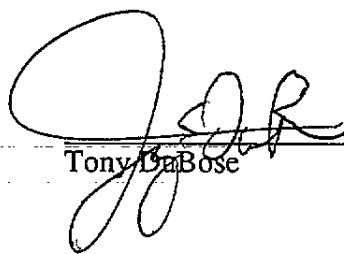

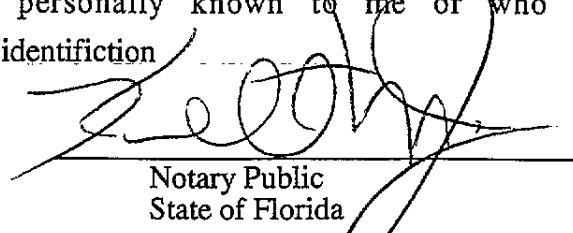
