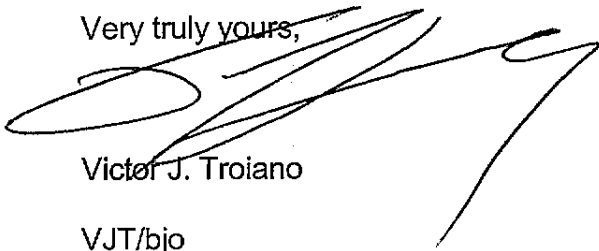

I, the undersigned, subscriber to these Articles of Incorporation, being duly licensed to practice the sale of real estate under the laws of the State of Florida, adopt these Articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, Florida Statute Chapter 621, and the other laws of the State of Florida.

ARTICLE I

NAME

The name of the professional service corporation is **DAVID A. GOFFE, P.A.**

ARTICLE II

PRINCIPAL OFFICE

The principal office and mailing address of this corporation is Post Office Box 1, Crystal Springs, Florida 33524.

ARTICLE III

PURPOSE

This professional service corporation is formed to engage in every phase and aspect of the practice of real estate sales as authorized by the issuance of a real estate brokers or salespersons' license, issued by the Department of Professional Regulation of the State of Florida. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds or any type of

investment and own real and personal property necessary for the rendering of professional services.

ARTICLE IV

TERM OF EXISTENCE

The professional service corporation shall have perpetual existence starting on the date these Articles of Incorporation are filed with the Florida Department of State.

ARTICLE V

CAPITAL STOCK

The capital stock of this professional service corporation shall be One Thousand (1,000) shares of common stock, having no par value.

None of the shares of the professional service corporation may be issued to anyone other than an individual duly licensed to practice real estate sales in the state of Florida by the Department of Business Regulations.

ARTICLE VI

REGISTERED OFFICE AND AGENT

The street address of the initial registered office is 1605 Tall Pines Trail, Lakeland, Florida 33810 and the name of the initial registered agent at that office is David A. Goffe.

ARTICLE VII

BOARD OF DIRECTORS

The business of this corporation shall be managed by its Board of Directors, the initial Board of Directors shall consist of one member. The names and address of the

ARTICLE IX

RESTRAINT ON ALIENATION OF SHARES

The shareholders of this professional service corporation shall have the power to include in the By-Laws, or by separate agreement adopted by a majority of the shareholders of the professional service corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer or other disposition of any of the outstanding stock of the professional service corporation by any of its shareholders, or in the event of the death of any of its shareholders. The manner and form, as well as the relevant terms, conditions and details, of the disposition shall be determined by the shareholders of the professional service corporation; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions is plainly noted on the certificate evidencing the ownership of such stock. No shareholder of the professional service corporation may sell or transfer stock in the corporation except to another individual who is eligible to be a shareholder of the professional service corporation, and the sale or transfer may be made only after it has been approved at a

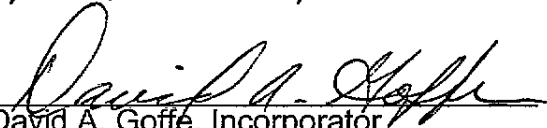
shareholder meeting especially called for that purpose. If any shareholder becomes legally disqualified to practice the sale of real estate in the state of Florida, is elected to public office, or accepts employment that places restrictions or limitations on the continuous rendering of such professional services, that shareholder's shares of stock shall immediately become subject to purchase by the professional service corporation in accordance with the By-Laws adopted by the shareholders.

ARTICLE X

AMENDMENT

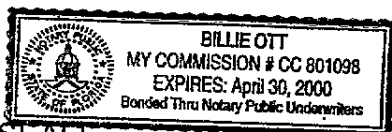

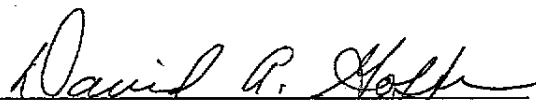
