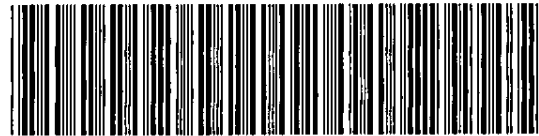

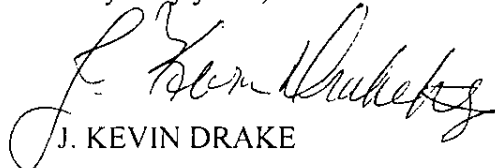

1. Name: The name of the Corporation is HUNTER MANAGEMENT SERVICES, INC.

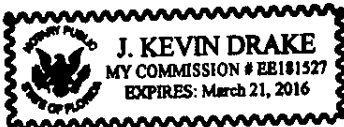
