ARTICLE I CORPORATE NAME

TALLAHASSEE, FLORIDA

The name of the corporation is C.A. & COMPANY OF SOUTH FLORIDA II, INC.

ARTICLE II DURATION

This corporation shall be perpetual existence commencing on the date of the filing of the Articles of Incorporation by the Department of State.

ARTICLE III PURPOSE
