The undersigned, acting as sole incorporator of a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be VTS Group, Inc. (the "Corporation").

ARTICLE II
