The undersigned subscriber to these articles of incorporation, being duly licensed practice law under the laws of the state of Florida, adopts these articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. EFFECTIVE DATE

ARTICLE I. NAME
