The name and address of the person signing these articles is H. Thomas Cato, 4632 Pipeline Road, Panama City, Florida 32405.

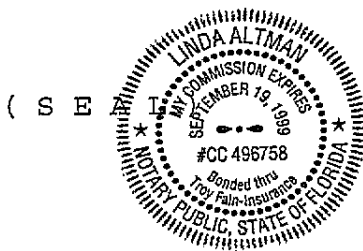
