


The original form mailed to us was given to a new accountant, who failed to file. He also waited until the last moment to file the 2000 corporate tax papers. When we received a notice of failure to file the UBR, we were unsure what it related to and initially believed it was referencing the papers sent out two weeks before and that a delay in processing had occurred. However, we made numerous telephonic attempts, on different days and times, to clarify the situation and repeatedly were told the lines were busy, to call back, and then were disconnected. With the events of 9/11 and its aftermath, we failed to expeditiously follow up on the initial warning. Before resolving the situation, we received the Notice of Administrative Dissolution (#P99000058651).

Under advice of another CPA, we wish to maintain our active corporate status and for this corporation to remain in good standing.

Also enclosed is our check in the amount of \$8.75 for a Certificate of Status.
