ARTICLE I CORPORATE NAME

ARTICLE II PURPOSE

The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the Law of the State of Florida other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the State of Florida Corporations Code.

ARTICLE III REGISTERED OFFICE/AGENT

ARTICLE IV AUTHORIZED CAPITAL STOCK

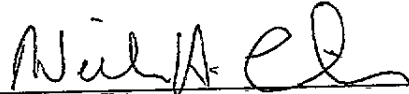
The total number of shares of which the Corporation shall have the authority to issue are 1000 shares, and the par value of each share shall be \$1.00.

IN WITNESS THEREOF, the undersigned incorporator has executed these Articles of Incorporation on this, the **29** day of June, 1999.

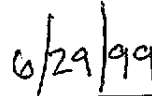
