

OF

The undersigned, acting as the sole incorporator, desiring to form a corporation in Florida pursuant to the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be CIRCLE J WHITEHOUSE DEVELOPMENT, INC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - TERM OF EXISTENCE

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.


ARTICLE IX - AMENDMENT TO ARTICLES


