The purpose of this corporation is to provide lawn maintenance, landscape and related services.

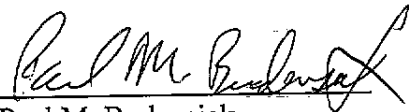
ARTICLE IV. CAPITAL STOCK

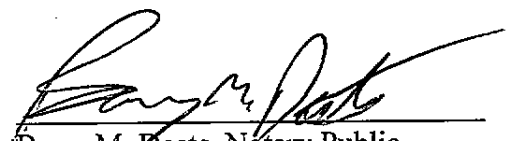
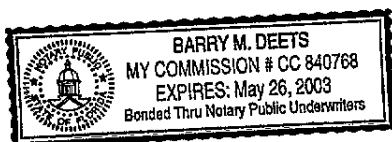
