ARTICLES OF INCORPORATION

RICHER RENOVATION INCORPORATED

The undersigned subscriber to these articles of Incorporation competent to contract, hereby associates himself to form a Corporation under the laws of the State of Florida.

ARTICLE I

The name of this Corporation is: RICHER RENOVATION INCORPORATED

ARTICLE II

The general nature of the business to be conducted and transacted by this Corporation is as follows: to engage in private or contract work for the purpose of remodeling, constructing, and repairing, in the field of carpentry and related activities.

A. The said Corporation shall have the additional powers to:

(1) Install, rebuild, and repair the interiors and exteriors of commercial and private establishments, including interior and exterior maintenance. To buy, sell, lease, rent and operate equipment, namely, machinery-tools-electrical-equipment-heavy-equipment, various types of construction equipment upon public or private property where not restricted.

(2) To hire and employ persons with qualifications essential to the performance of the business.

B. The said Corporation shall also have the power to:

(1) Conduct business in, have one or more offices in, buy, sell, hold mortgage, lease, convey or otherwise dispose of real and personal property-Real Estate-franchises-copyrights-trademarks and licenses in the State of Florida and in all other states and countries.

(2) To contract debts, borrow money, issue and sell or pledge bonds, debentures, notes, and other evidence of indebtedness, and execute such mortgages, transfers of Corporated property, or other instruments to secure the payment of Corporate indebtedness as required.

(3) To purchase Corporate assets of any other Corporation and engage in the same character of business.

(4) to guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the Capital stock of, or any Bonds, Securities, or other evidences of indebtedness created by any other State or Government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

C. The Corporation shall have all other powers granted by the State of Florida, and such other powers as may be reasonably necessary for the Corporate business herein above specified. This Corporation is to exist perpetually.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is: Seventy five thousand shares; (75,000.00), of the par value of (\$1.00), One dollar per share.

ARTICLE IV INITIAL CAPITAL

The amount of Capital with which this Corporation will begin this business is Five Hundred Dollars, (\$500.00).

ARTICLE V

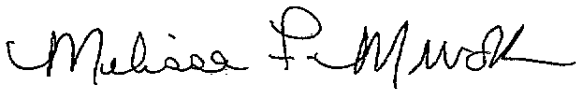
