
This report is being returned to you soon after it was received. The form was completed and returned as soon as possible. The similar UBR form that should have been sent in earlier in the year was never received by the company and thus, not filed.

Sound Ground, Inc. was incorporated (filed) on June 28, 1999. The business is located in Bradenton in Manatee County, Florida. Sound Ground, Inc. is a small start up family business. Soon after incorporation, the principals of the company got married, bought a new house and moved. We can only presume that the time for mail forwarding had expired by the time the 2000 UBR was mailed.

Sound Ground was a brand new company and had no prior experience filing UBR's and therefore had no real notice that they were supposed to be filing such a form. The penalty exceeds the 1999 revenue of the company and would impose a harsh burden on a company that has complied with the UBR filing as soon as they were aware of the requirement.

I do not believe that the failure to timely file the 2000 UBR was the fault of Sound Ground, Inc., and respectfully request that the Division waive the penalty.
