#### **ARTICLE I - NAME**

The name of this corporation is **Scherer Installations, Inc.** and its principal office and mailing address is: **9915 Tamiami Trail North, Naples, FL 34108.** 

#### **ARTICLE II - NATURE**

The nature of the business to be transacted by this corporation is:
window and glass installation. To erect dwellings, apartment houses and other
buildings, private or public, of all kinds, and to sell or rent the same. To lay out,
