# ARTICLES OF INCORPORATION OF ARC SYSTEMS, INC.

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, Florida Statutes, Chapter 607, adopts the following Articles of Incorporation for such corporation:

#### Article One - Name

The name of this corporation is ARC Systems, Inc.

#### Article Two - Duration

The period of its duration is perpetual.

#### Article Three – Purpose

(A) To buy, sell, hire, lease, broker, import, export, deal in, operate, or use motors, engines, or other machinery or devices of every kind and description for the generation of power, for the propulsion of such above mentioned airships, aero, and other planes, machines, contrivances, and devices for aerial operation and navigation and all machinery, appliances, tools, supplies, materials, parts, accessories, and equipment, or other paraphernalia used or capable of being used in the construction or use of the same; and in conjunction therewith to render to any person, firm, association, corporation, or governmental body or agency engaged in any lawful undertaking, enterprise, or business, services of a technical, scientific, business, or management nature.

- (B) To carry on its operations and conduct business in any state, in the District of Columbia, and in any territory, dependency, or possession of the United States, and in any foreign country;
- (C) Additionally, this corporation is organized under the corporation laws of this state may now or hereafter lawfully do, to do, either as principal or agent and either alone or in connection with other corporations, firms, or individuals, all and everything necessary, suitable, convenient, or proper for, or in connection with, or incident to, the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated, or designed directly or indirectly to promote the interests of this corporation or to enhance the value of its business plan; and in general to do any and all things and exercise any and all powers, rights, and privileges which a corporation may now or hereafter be organized to do or to exercise under the corporation laws of this state or under any act amending those laws, supplemental thereto, or substituted therefore.
- (D) It is the intent of this corporation to elect an "S" tax status under section 2553 of the Internal Revenue Code, as amended.

#### **Article Four - Capital Stock**

The corporation is authorized to issue one hundred shares, all of one class, at \$5.00 par value.
