Article I - Name

Article II - Duration

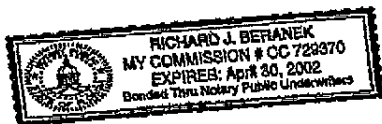


