ARTICLE OF INCORPORATION

OF

**ARTICLE ONE**

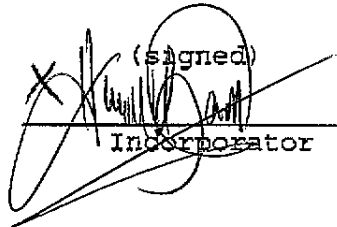
#### ARTICLE EIGHT
