The undersigned, acting as the incorporator of the corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME: The name of the corporation is DORADO, INC.

ARTICLE II

REGISTERED OFFICE AND REGISTERED AGENT: The street address and telephone number of the initial registered office is 411 ARREDONDO AVE., ST. AUGUSTINE, FLORIDA 32084, (904) 829-6365.

The name of the initial registered agent is ERIC R. COOPER, who is familiar with the accepts of the duties and responsibilities as Registered Agent for said Corporation.

BOARD OF DIRECTORS: The initial board of directors shall consist of one (1) member. The name and address of this person who is to serve as the director is as follows:




