## ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: Investment & Consulting Group O.I.L., Inc. The principal office of the Corporation is 117 River Chase Drive, Orlando, Florida 32807. The mailing address of the Corporation is 200 E. Robinson Street, Suite 500, Orlando, Florida 32801.
