ARTICLE I

The name of this corporation is Renew Systems of Georgia, Inc.

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

The purpose of this corporation is external cleaning of commercial building and all other lawful buisness.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

ARTICLE V - PRE EMPTIVE RIGHTS

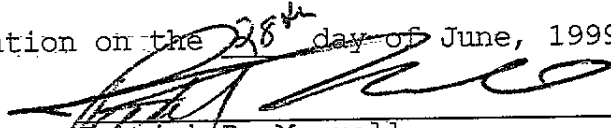
ARTICLE IX - BYLAWS

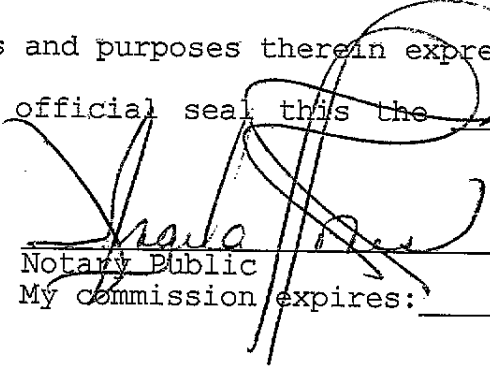

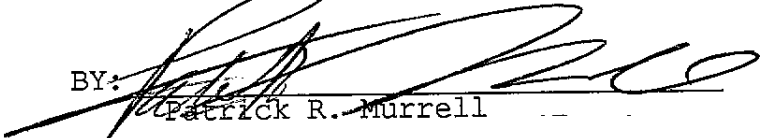

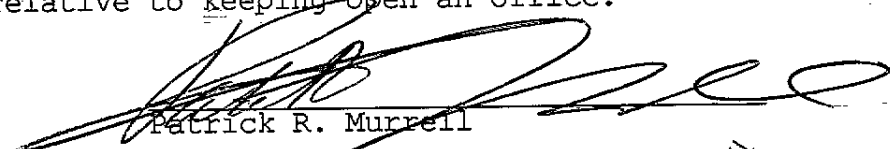
