The undersigned incorporator makes and files with the Department of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for the profit under the laws of the State of Florida.

ARTICLE I
Name

The name of the corporation is J. PRICE HOLDINGS, INC.

Principal Office/Mailing Address

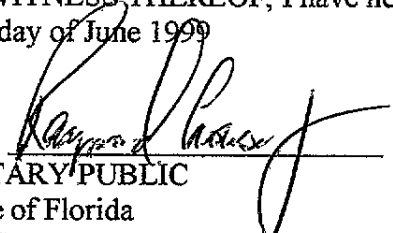

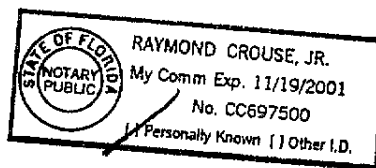
