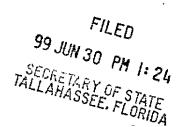

# ARTICLES OF INCORPORATION OF The Great Pizza Co.



#### Article I

Name. The name of this Corporation is The Great Pizza Co.

#### Article II

<u>Principal Place of Business</u>. The principal place of business and mailing address of the Corporation is 5205-B NW 39<sup>th</sup> Ave., Gainesville, Fl 32606.

## Article III

<u>Capital Stock</u>. This Corporation is authorized to issue 1,000,000 shares of One Dollar (\$1.00) par value common stock. All shareholders shall have preemptive rights in future stock sales by the corporation.

### Article IV

Effective Date. The effective date for the inception of the Corporation is June 29, 1999.

<u>Duration</u>. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

# Article VIII

<u>Purpose.</u> The purpose of this Corporation is to engage in activities or businesses permitted under the laws of the United States and under the Florida General Corporation Act.

#### Article IX

By-Laws. The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and Shareholders.

#### Article X

<u>Initial Board of Directors</u>. The Corporation shall have one (1) Director initially. The number of Directors may either be increased or diminished from time to time by the By-Laws, but it shall never by less than one.
