This corporation is authorized to issue one thousand (1,000) shares of One Dollar (\$1.00) par value common stock.



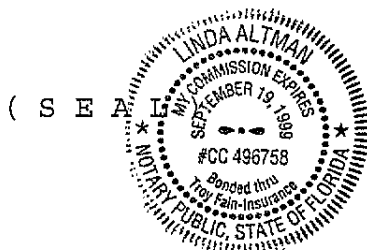
