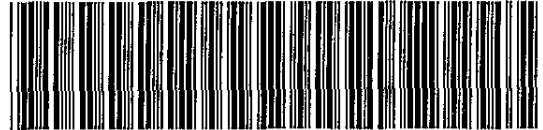

It has come to my attention that Joan Headley of the Miami-Dade Resident College was asked about the address of Workforce Management by the Inspector General on September 11, 2003. In an effort to clear up any misunderstanding I am writing this letter.

Workforce Management was engaged in moving offices in FY 2001- 2003. In doing so we missed receiving mail. It was during this period that we failed to receive our corporation UBR reports in the mail and then we were subsequently administratively dissolved. While still in the process of moving we operated for a short period at the address of 4743 N.W. 183<sup>RD</sup> Street, Miami, Florida.

Upon being made aware of our administrative dissolution we then reinstated. It was during this time we were moving from one location to another and needed to expedite an office street address. We choose to use the address associated with our registered agent Andrea Lyew who shared the same address with Joan Headley at that time.

Recently, we have settled our business at the street address of 7411 N.W. 186 Street, Miami, Florida. At the very next UBR report period we will amend the principal office address to our present location. We do hope that this clears up any concern relating to the registered agent's address.


