ARTICLES OF INCORPORATION
of
CarBarCo, Inc.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

Name

The name of the corporation is CarBarCo, Inc.

ARTICLE II.

Address

ARTICLE III.

Duration

The duration of the corporation is perpetual.

The name and address of the person signing these Articles is: Jan Ann Carter, 603 Kirkwood Ter. N., St. Petersburg FL 33701.

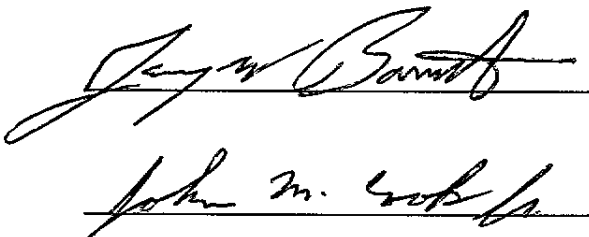

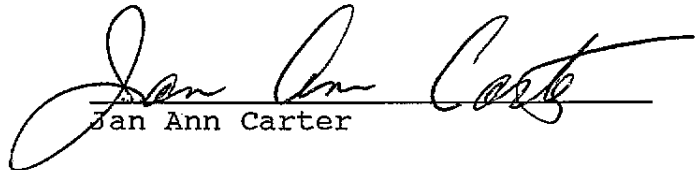
Amendments

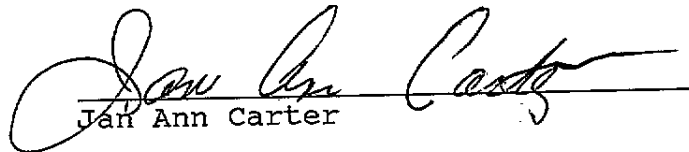
