ARTICLE I

NAME

The name of this corporation is Garvel, Inc.

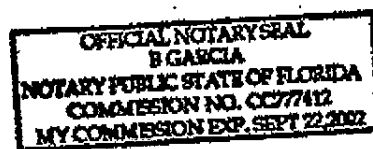
