ARTICLE I - NAME

The name of this corporation is EBB TIDE CONDOMINIUM, INC., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Florida Department of State.

ARTICLE III - PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the United States and of this State.

vested in the Board of Directors and the shareholders.


ARTICLE IX - INDEMNIFICATION

allowed under said Bylaws.



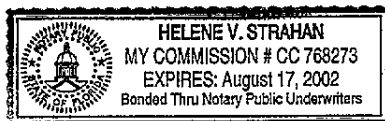
