

The undersigned subscribers to these Articles of Incorporation, being natural persons competent to contract, hereby associate themselves together to form a corporation under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I

Name of Corporation

The name of this Corporation is METRO'S 2000, INC.

ARTICLE II

Purpose of Corporation

The corporation may engage in any activity or business permitted under the laws of the United States and of this State of Florida and of every state in the United States, its possessions or territories, including but not limited to, the transaction of any and all lawful business related to ownership and operation of restaurants and retail and wholesale food sales, take-out meals and sales of food products.

ARTICLE III

Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is Five Thousand (5,000) shares of common stock having a par value of One Dollar (\$1.00) per share. The consideration to be paid for each share shall be fixed by the Board of Directors.

ARTICLE IV

Initial Capital

The amount of capital with which the corporation will begin business is Five Hundred Dollars (\$500.00).

ARTICLE V

Term of Existence

This corporation is to exist perpetually.

ARTICLE VI

Address

The initial post office address of the principal office of this corporation in the State of Florida is 612 Barnes Blvd., Rockledge, FL 32955. The Board of Directors may from time to time move the principal office to any other location and address in Florida.

ARTICLE VII

Directors

This corporation shall have one (1) Director initially. The number of Directors may be increased or diminished from time to time by the By-Laws adopted by the stockholders, but shall never be less than one (1).

Amendment






