ARTICLES OF INCORPORATION
OF
DOUGLAS M. FLETCHER, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

Article I - Name

The name of the corporation is DOUGLAS M. FLETCHER, INC.

Article II - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article III - Office Address

The address of the principal office of the corporation and also the mailing address of the corporation is 1427 Southeast 8th Avenue, Apt. D211, Deerfield Beach, Florida 33441.

Article IV - Capital Stock

This corporation is authorized to issue Five Thousand (5,000) shares of One Dollar (\$1.00) par value common stock.

Article V - Initial Registered Office and Agent

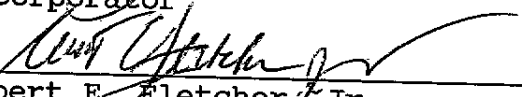
Article IX - Amendment
