ARTICLES OF INCORPORATION

OF

I, the undersigned, being of legal age, do hereby form a corporation for profit under the laws of the State of Florida authorizing the formation of corporations.

ARTICLE I - NAME

The name of the corporation is: HOME NETWORK, INC.

ARTICLE II - NATURE OF BUSINESS




