ARTICLES OF INCORPORATION

ROBERT C. DAVIS PAINTING CONTRACTOR, INC.

WE, the undersigned, form this **CORPORATION** **FOR PROFIT** pursuant to Chapter 607.01, et. seq. of the Florida Statutes.

ARTICLE I

The name of the corporation is **ROBERT C. DAVIS PAINTING CONTRACTOR, INC.**
The Corporation shall operate under a business name, and has filed or shall file the appropriate documentation to do business under the name of " ROBERT C. DAVIS PAINTING ".

ARTICLE II

The corporation shall exist perpetually.

ARTICLE II A

The corporation shall issue one hundred (100) shares of common stock with a par value of One (\$1.00) Dollar per share. The shares shall not be traded publicly.





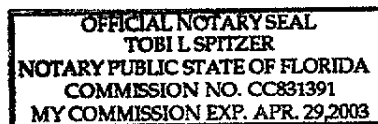
