ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is MOTO CYCO WORLD OF CLEARWATER, INC. The principal office and mailing address of this corporation is: 11641 US Highway 19, Clearwater, FL 33764.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE X - AMENDMENT

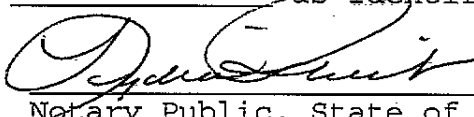
