The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I-NAME

The initial street address of the principal office of this corporation is to be at




ARTICLE XI-EFFECTIVE DATE
