Pursuant to the provisions of Florida Statute 607.1001 et seq., the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The present name of the corporation is **FRANANDU, INC.**
2. The following amendments to the Articles of Incorporation were adopted by a unanimous vote of the shareholders of the Corporation on February 12, 2001, in the manner prescribed by the Florida General Corporation Act:

Article I of the Articles of Incorporation of **FRANANDU, INC.**, shall be amended by deleting Article I and adding the following in its place:

ARTICLE I: NAME

The name of the Corporation shall be **FRANK RAPPA, P.A.**

Article II of the Articles of Incorporation of **FRANANDU, INC.**, shall be amended by deleting Article II and adding the following in its place:
