We ask your consideration for our situation during springtime this year, especially at the time of the deadline for filing our UBR report. We moved across country to Florida last year because my wife's father, Arnold Lancaster, was dying of prostate cancer, dropping everything to rush to his side less than two months after his surgery. We regularly drove from our home in New Smyrna Beach to the Lancaster's residence in Deerhaven, west of Deland, about a one-hour drive. However, during late April and early May of 2000, Daddy Lancaster's struggle became even more difficult. We had to move to their house to help Momma Lancaster with Daddy, and I had to drive our adopted daughter Lori over to New Smyrna Beach high school and back to Deerhaven each day. Lori herself requires 24-hour care, due to cerebral palsy and other multiple disabilities.

So as you can see, we had our hands full providing care for Daddy Lancaster and our daughter during the time we were supposed to file our UBR. I was responsible, as CEO of Interest-Driven Learning, but I was also juggling all of the other responsibilities of a start-up corporation with our commitment to the Lancasters. Arnold Lancaster did finally die on May 18th (Allen Summerhill Funeral Home, Deland (904 775-4664)), despite all our efforts and the remarkable support he received from the Deerhaven community. Filing the UBR was in the back of my mind during all of this, but I was hoping I had longer. When I did realize I had missed the deadline, I sent my check for \$150 immediately.

Though all start-up corporations struggle, we feel our struggles have been exceptional this past year. We are translating our special reading and writing software for preschoolers from Macintosh format to Windows format. Such a development effort usually requires a large team and a budget of between \$100 200 K, and we have been using our home equity and credit cards for a low-budget push to make a high quality product. We are committed to making this product available because we know how much it will mean to all children struggling to learn to read and write.

We respectfully request your support in our time of grief and stress. We are hoping not to have to pay the extra \$400 fine.
