CAPITAL STOCK

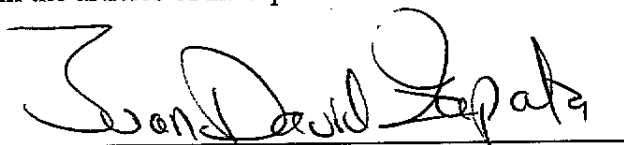
The aggregate number of shares which the corporation is authorized to issue is ten hundred (1,000) shares of common stock, of \$1.00 par value.

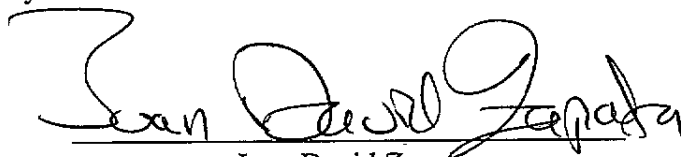
This corporation may be a subChapter S corporation as defined by the Internal Revenue Code.
