ARTICLE I-NAME AND PRINCIPAL ADDRESS

The name of this corporation is ASL ASSOCIATES, INC. - DEAF SERVICE CENTER, and the principal address is 9087 Berens Street, Jacksonville, Florida 32210.

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III-PURPOSE
