ARTICLES OF INCORPORATION

OF

RAINMAKER ENTERTAINMENT GROUP, INC.

I, the undersigned natural person of the age of eighteen (18) years or more, acting as incorporator of a corporation under the Florida General Business Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the Corporation is RAINMAKER ENTERTAINMENT GROUP, INC.

ARTICLE TWO

The period of duration is perpetual.

ARTICLE THREE

The purpose or purposes for which the Corporation is organized are:

- (a) To engage in the business to conduct and advertise wrestling events in South America, Central America, the Caribbean Basin, Puerto Rico and Mexico and other affiliated activities including other non-related promotional activities.
- (b) To do everything necessary, reasonable, proper, advisable and/or convenient for the accomplishment or furtherance of such purposes.
